Under a recently passed by-law of the College Council, four distinguished men were named to be the first Honorary Fellows of St. John's College.

The number of honorary fellows is limited to ten at any one time. An honorary fellowship may be offered by the College to those who are distinguished in the fields of religion or education or public service. The fellowships are not limited to those who were former members of the College, although it is probable that the bulk of them always will be. Some connection with the College is, however, a condition of election.

In 1985, the first honorary fellows were named to coincide with the 75th Anniversary celebrations of the University of Queensland.

College Elects First Honorary Fellows

The Right Honourable **Sir Zelman Cowen**, Provost of Orial College, Oxford, and former Governor-General of Australia; formerly Vice-Chancellor of the Universities of Queensland and New England. Sir Zelman delivered the first Old Johnian Oration. He has always maintained a keen interest in College life in all its forms, beginning with his undergraduate career at the University of Melbourne, where he was a non-resident member of Ormond College. As Governor-General, he came to St. John's on a couple of occasions for the

laying of the foundation stone of the Chapel/Drama Theatre and also to attend a gathering marking the seventieth anniversary of the College.

The Honourable Mr. Justice Edwin Stanley, formerly a Judge of the Supreme Court of Queensland and the first University of Queensland graduate to be elected to the University Senate. Justice Stanley was both an undergraduate and a tutor of St. John's College and served for a long period as a member of the College Council. He has visited the College frequently over the past years and has always kept a keen interest in all its activities.

Dr. Norman Henry Fisher, A.O., D.Sc., formerly the chief geologist of the Commonwealth Bureau of Mineral Resources and director of a number of mining companies. Dr. Fisher has been the recipient of many national and international awards in geology and served as President of the Australian Geological Society. He was resident in College for the whole of his undergraduate course and has always kept a strong interest in the affairs of the College.

Dr. Selim Abraham Mellick, F.R.A.C.S., a distinguished surgeon who recently retired as the longest serving member of the surgical staff of the Princess Alexandra Hospital in Brisbane. Dr. Mellick has been a Hunterian Professor of the Royal College of Surgeons and is a Fellow and a Governor of the American College of Surgeons. He served as Chairman of the Silver Jubilee Building Appeal Committee of the College.

It is hoped that a ceremony of recognition and installation may be held at the College at a time when it is possible to gather together all the Honorary Fellows.
